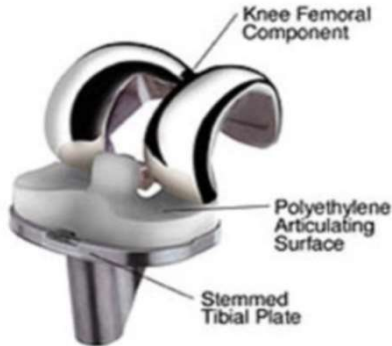

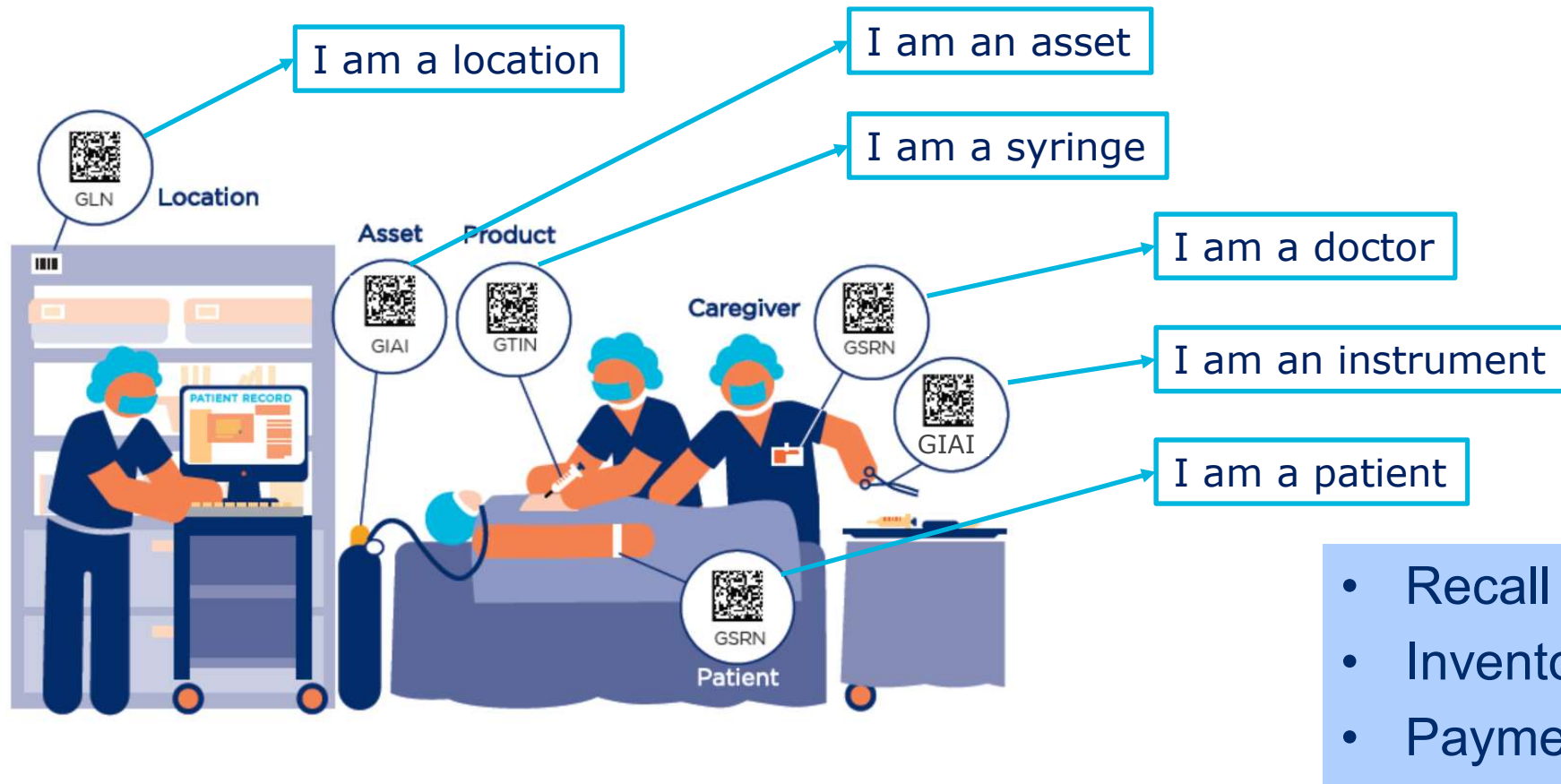
Track and Trace in the Hospital

GS1 Standards enable many applications and uses within industry sectors



What are the regulators saying?



Medical Devices: Unique Device Identification (UDI)

- (01) Product Code/GTIN
- (10) Batch
- (17) Expiry
- Serial number (where applicable)



Deadline for EU: May 2020

Note: FDA regulation already in place

Directive



Pharmaceuticals: Falsified Medicines Directive (FMD)

- (01) Product Code/GTIN
- (10) Batch
- (17) Expiry
- (21) Serial Number

Deadline for EU: 9th Feb 2019



Storage and traceability requirements in the EU for Medical Devices

(from May 2020)



DID YOU KNOW?

All Hospitals in EU will be required to capture and store the barcode in their IT systems – starting with Class 3 Medical Devices (eg: implants)

Storage:

- store and keep, ***preferably by electronic means***, the UDI for class 3 implantable devices and for devices identified via implementing acts
- Only class 3 implantable devices for **health institutions**

Traceability:

- identify any operators/health institution to whom have directly supplied a device and any operator who has directly supplied them with a device: **one-up-one-down traceability model**
- Manufacturers will be required to **include the UDI in Recall and Field Safety Notices**

We welcomed back Professor Terence Stephenson, Chair of the General Medical Council, who recognised that the challenge he had set at last year's conference of getting real clinical evidence was going to be met later today in Dr Goddard's presentation on the use of GS1 standards in endoscopy. Dr Goddard, Registrar at the Royal College of Physicians and Consultant at Royal Derby Hospital, made the benefits clear. They now have data that they've never had before - they scan the co-morbidities of their patients, they track all their consumables and they know their complication data. Their reporting has improved, their stock control is better and they can now have conversations about how and why procedure runs late or goes wrong. They never had this before and as Dr Goddard himself said, "it has to be the way forward."

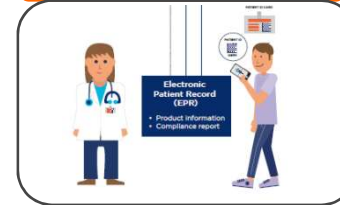

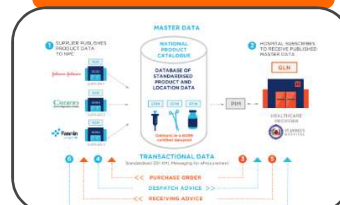

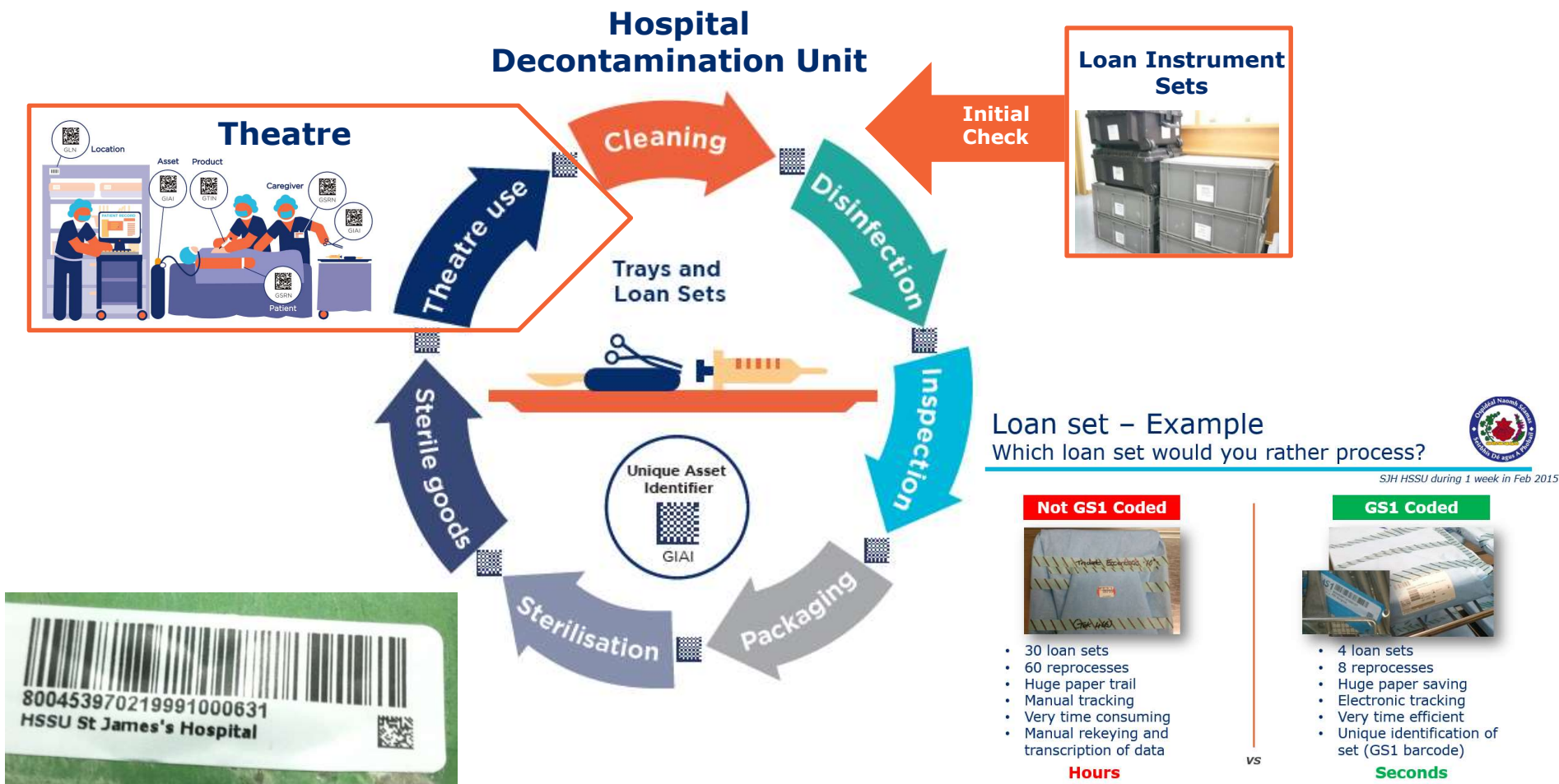

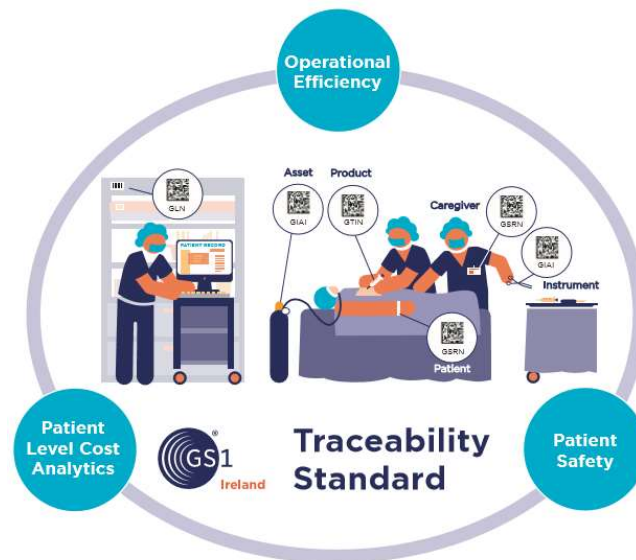
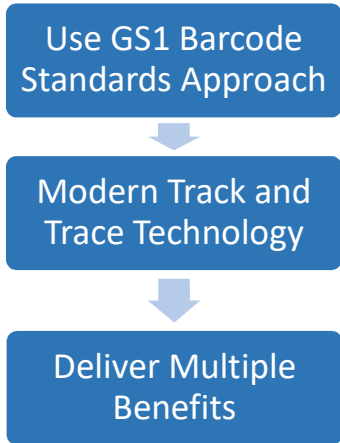
Example of Standard Patient ID in the UK

SJH can now track 89% of cost to the patient (prev. 4%)

Operational Efficiency

- Automation of product supply chain processes for nursing
- Make additional time available for patient centric activities
- Managed minimum inventory levels

Patient Safety

- Product Traceability to individual patients
- Product Expiry Identification

Patient Level Cost Analytics

- Increased visibility of real-time patient and procedure level costs
- Improved data analytics for decision making

Operational efficiency at St James's Hospital



Before

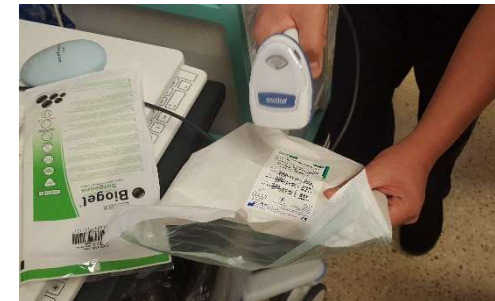
- 20 hours per week to check and reorder stock (and other stock activities)
- Over-qualified role doing non-value added activities
- Limited Time for patient care

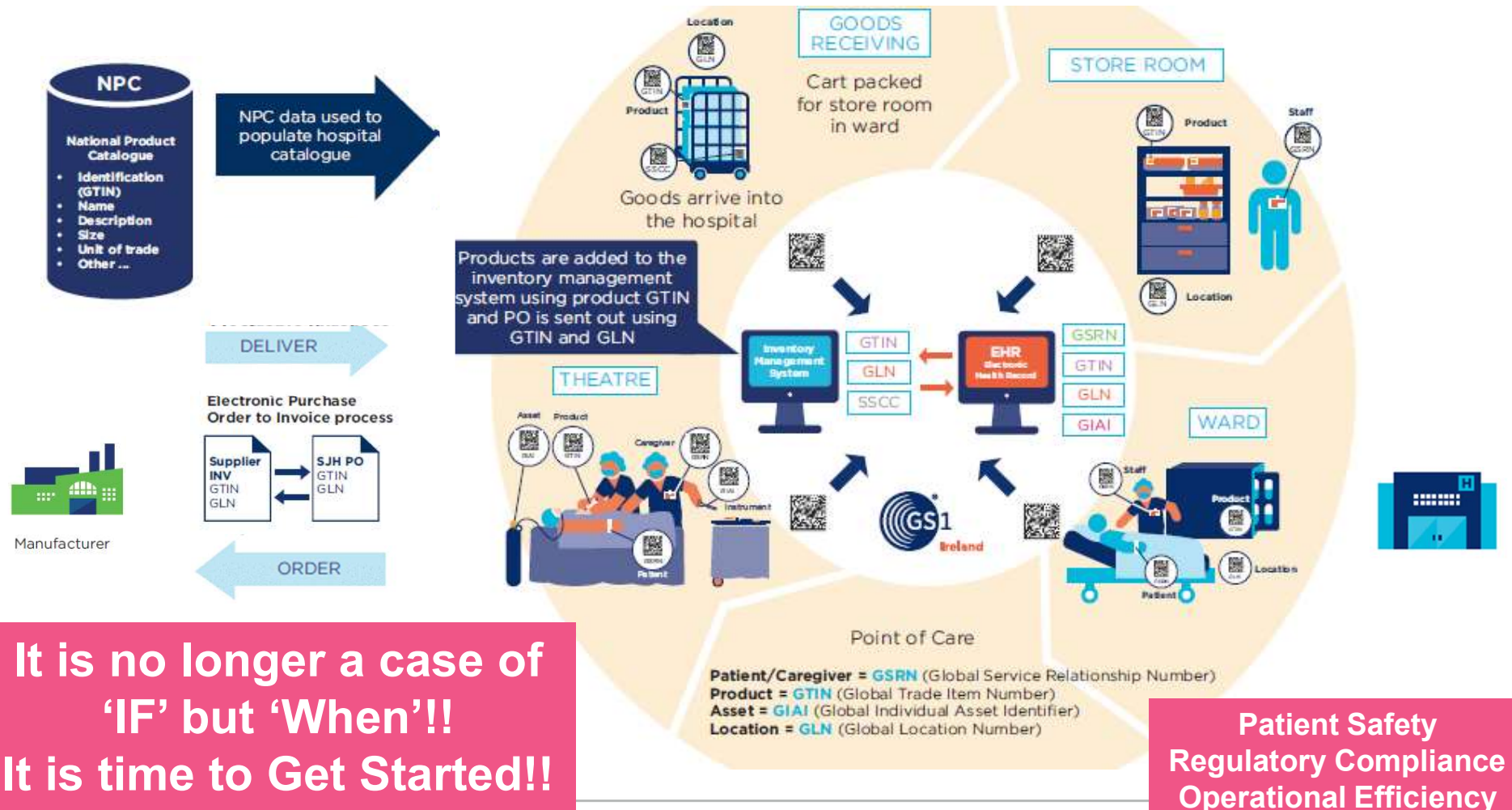
